## The Consecration of a new Lodge

It is important to understand the significance of the Consecration ceremony of a new Masonic Lodge and the symbolic use of the various elements employed therein. According to Mackey's Jurisprudence of Freemasonry new Lodges have, from the earliest times, been consecrated to the purpose for which they have been formed. By this act, the Lodge is set apart for the cultivation of the great tenets of Freemasonry. The word consecration is understood today to have a religious connotation, but it originally had a much wider meaning, namely to be dedicated to a moral and spiritual purpose. The consecration of a Lodge is thus the traditional ceremony that activates the Lodge and firmly links its labours and its members to the Glory of the GAOTU and its usefulness in society. Prior to the formation of the Grand Lodge of England in 1717, Masonic Lodges existed and held meetings without a Charter or a Warrant. The granting of Lodge Charters thereafter became a very significant event and while it always remains property of the issuing Grand Lodge, the Charter today contains the names of the Lodge's founder members and of the first Presiding Master and the Wardens and it is the very cement which binds the founder members and the Grand Lodge together.

The first reference to the word "Lodge" did not refer to a building, but rather to the members of the Lodge and while the members will change with the passage of time, the Lodge will always exist as it is consecrated to the service of the GAOTU and to mankind. We read in the book of Chronicles in the VSL that King Solomon requested King Hiram of Tyre to send him cedar, pine and algum logs to build the Temple in Jerusalem and he offered corn, wine and oil as payment for this material. From the earliest times, the symbolic wages of corn, wine and oil have therefore been used in the consecration of Masonic Lodges. Corn is associated with nourishment, wine with refreshment and oil with peace and joy and these elements are, to Freemasons, a threefold representation of the Divine blessings from the GAOTU to the members who comprise the Lodge, both at the time of its consecration and throughout the years of its existence. It has therefore become accepted that the consecration of a Lodge is a Masonic Rite, religious in form, by which a new Lodge is blessed and dedicated to the purpose for which it is constituted, namely to practise Freemasonry.

In his message to Hiram, Solomon also states that he will dedicate the Temple to God by burning fragrant incense therein. The use of incense in the consecration ceremony has always been a symbol of the prayer of the faithful rising to Heaven. Its fragrance, which will permeate every corner of the Lodge, is symbolical of the good deeds which will be performed by the Lodge members and which will bring relief to the many recipients who are less fortunate than themselves. With these elements as the solid foundation of a new Lodge, it is hoped that the members will be inspired to build a multi-cultural Brotherhood of good men who will practice brotherly love, charity and truth and who will be united in the enhancement of wisdom, high moral standards, equality and justice for all persons.

We also read in the book of Deuteronomy in the VSL that it was the custom to dedicate a new residence to God with prayer, praise and thanksgiving, for no sensible man could imagine that he could dwell safely in any house lest it be under the immediate protection of God. Once a Lodge has therefore been consecrated, it must also be dedicated to the GAOTU. We thus perform re-dedication ceremonies for Lodges which have reached particularly significant milestones in their lifetimes, such as 50 year, 100 year or even 250 year anniversaries. It is important for the present members to recall their Lodge's history, to re-emphasise the purpose for their formation and to re-affirm the reasons for their continued existence.

Once consecrated and dedicated, the Lodge must be constituted as a permanently registered Lodge under the jurisdiction of the Grand Lodge. This will give the Lodge the constitutional authority to perform the actions for which it was established. The Lodge may then assume its rank and proceed to enjoy all the privileges of a duly Chartered or Warranted Lodge.
